I think you will enjoy this recent article in The Wall Street Journal, written by Niccolò Machiavelli (Josef Joffe). Russia would have been well advised to pull up their old playbook and make the Ukraine an offer for the reacquisition of Crimea. Certainly, the negotiations between U.S. Secretary of State William H. Seward and the Russian minister to the United States Eduard de Stoeckl for the purchase of Alaska in 1867 for \$7.2 million went rather smoothly (would be \$115 million today). Crimea is more developed, and I think Ukraine would have to seriously consider the option of a get-out-of-debt-free card from Putin, though the purchase price would need to be significant. Is there no modern-day equivalent of Seward or Stoeckl to begin such an economic negotiation? We can only hope for a logical solution, instead of force. Regrettably, the latest moves have made it near impossible for logic to prevail.
